
## More About Our Values

Early childhood (from prenatal to age 5) is a critical period of development in a child's life and brain growth. During these first years, emotionally nourishing relationships lay the foundation for lifelong health, well-being and educational achievement. By supporting the caring adults who touch the lives of infants, toddlers and preschoolers, The Children's Trust maximizes its long-term impact in ensuring a bright future.

Youth development support across childhood from kindergarten through school completion are also important to sustain early childhood investments. If we provide safe and enriching, high-quality after-school and summer programming that meets the needs of school-aged children and youth, and supports academic, health, and social and emotional wellness, then children and youth will succeed academically, make good choices for healthy lifestyles and prosocial behaviors, and successfully make the transition to young adulthood.

Continuous learning and quality improvement enhances the development of high-quality services that achieve reach and impact for children and families. This requires that programs recruit, train and retain qualified and engaging staff members; conduct ongoing performance assessments; practice growth planning; and utilize program and professional development supports. The Children's Trust practices continuous learning at the contract, initiative and priority investment area levels across its portfolio of investments.

Community empowerment is essential to longterm and meaningful engagement, advocacy and collaboration with community stakeholders at all levels. This leads to leveraged investments, programs and initiatives that achieve collective impact. It is imperative to seek input from youth, families, providers and partners to inform The Children's Trust's practices and priorities as a whole. It is also essential to provide community-based



organizations with capacity-building support and connection to funding opportunities, collaborative partnerships and more. Another key to community empowerment is to inspire and inform the public about available programs and resources for children and families to support them in achieving their full potential.

A whole child focus nurtures all areas of child and youth development. This includes multiple areas of growth, such as social, emotional, physical, cognitive, approaches to learning, and health. It is also critical to ensure resources to meet basic needs that address the social determinants of health and development.

Populations with greater needs for resources and supports include children and youth with disabilities, as well as those affected by adverse childhood experiences (ACEs) or involved in the child dependency or delinquency systems.

This may include children and families residing in neighborhoods affected by poverty, crime, unemployment, community violence and trauma. It is critical to amplify strengths and build resilience to counter the negative impacts of child abuse or neglect, exposure to family and community violence, family mental health issues, legal issues, family housing instability, and extreme poverty. Children and youth with disabilities require intentional supports that ensure they are welcomed into all funded programs and served effectively with reasonable accommodations.

Evidence-based practices and programs (EBPs) offer the best chances of success for children and families. When sufficient evidence exists relevant to the populations and services to be funded, EBPs should be incorporated into programming investments.

- Reflect child, family and community levels
- Include different ages and populations
- Incorporate quantitative/ administrative data and qualitative/self-reported perceptions
- Ensure a positive, strengths-based view
- Are easily communicated
- Complement other community work
- Provide quality data on a timely basis
- Parallel program performance measures
