**Background:** Florida Statutes, section 218.39, requires an independent certified public accountant conduct an annual financial audit of The Children's Trust's accounts and records within nine months of the end of its fiscal year. Additionally, The Children's Trust's bylaws allow the use of the same external auditor for up to five consecutive years.

The Finance and Operations Committee initially selected Marcum LLP through a competitive solicitation process in 2018. The contract is in its fourth year and will end on July 31, 2022. The recommendation to contract with Marcum LLP for the fifth and final year is based on its satisfactory performance of The Children's Trust's financial audit. Factors considered in Marcum LLP's satisfactory performance rating include the auditor firm's competence, cooperativeness, thoroughness, audit reasonable performance, and the auditor's satisfaction of pertinent deadlines.

**Description of Services:** Services provided by Marcum LLP will include but are not limited to the following:

- perform a financial audit in accordance with auditing standards;
- review and make recommendations for required note disclosures for The Children's Trust Annual Comprehensive Financial Report (ACFR);
- issue reports following the completion of the financial audit; and
- provide guidance on governmental accounting standards.

Additionally, The Children's Trust requests \$50,000.00 contingency for IT budgeted enhancement projects to be added to the agreements listed above, as needed. Projects are currently estimated at least one year before the projects start, as such this contingency will cover additional costs that might be incurred during the project that may not have been previously estimated. This allows for greater flexibility when completing projects and ensures all necessary enhancements can be completed during the project timeline, rather than waiting another fiscal year to complete all the required enhancements.

**Background:** The Children's Trust leases software services from several vendors. These software services are crucial to the daily business activities of staff by facilitating their ability to perform assigned tasks, including interacting with providers efficiently, capturing data, tracking funded program activities, and overall program performance.

The current budget requested has increased from last year due to the need to upgrade our financial software to the newest version for security purposes with MergeIT, the transition to WebAuthor as the new vendor to host our website to address platform security issues and provide staff more direct control of content and enhancements, and WELS expanding their services in providing a user application for streamlining the payment process to early childhood educators participating in the salary supplement program. The software services that are license payments are being presented for renewal following the procurement policy, Exemption to Formal Competitive Solicitation Process, G-9, licenses, and permits for the operation of The Children's Trust. The board previously approved these services, and their renewal allows for the continuation of The Children's Trust operations. For the software services that are not licenses, The Children's Trust requests a procurement waiver.

**Request for Procurement Waiver (requires approval of a 2/3 vote of board members present):** This resolution is requesting a waiver of the procurement process to negotiate and execute agreements with vendors for software solutions that were initially selected through a competitive solicitation and are now tailored to meet The Children's Trust's operational needs.

Once the services were solicited, the staff at The Children's Trust have worked with the software vendors to customize the software, thereby making it specific to The Children's Trust use, and concomitantly resulting in a software product adapted for The Trust. Due to the investment in time, effort and funding, it is not practical or economical to solicit these services.

Additionally, two of the services (Project Management Tool and CollaborNation) were procured through a quote process, per the procurement policy, and the Miami IDEAS Consortium was initially a match contract. The table below describes the procurement method and background for each service.

**Description of Services:** Regardless of their circumstances, all families face inevitable parenting challenges and can benefit from supports. Effective, consistent, and supportive parenting prepares children for a lifetime of success. The Children's Trust funds a continuum of evidence-based and promising programs including group, advocacy, home visitation, and individual supports. Programs offer professional and peer support, educational, and skill-building opportunities for parents and primary caregivers from the prenatal period through children's transition to adulthood, with the goals of supporting positive parent-child interaction and communication.

Additionally, some group-based advocacy programs emphasize parent leadership development and civic engagement, allowing parents to become more engaged in child-serving systems and advocating for their own children's success, and for improved family-centered services.

Programs are offered in homes, pediatric offices, and other settings, such as child care centers and schools, in high-need communities. They provide skill-building opportunities for parents of children birth to 18 (up to 22 for families with youth with disabilities) with a focus on child health, development, and school readiness/success through encouraging positive and nurturing parent-child relationships. Parents can connect with and support each other as they learn and practice new parenting skills. Programs can offer services by virtual delivery for some participants using telehealth and other technology to be responsive to participant needs.

**Description of Services:** The Children's Trust's Family Strengthening initiative is a cross-cutting funding approach that focuses on families with children and youth experiencing challenges such as disruptive child behavior, tumultuous parent-child relationships, youth violence, and parent mental health and/or substance abuse issues. The evidence-based, individualized parenting and clinical intervention services are accessible in community and home environments to support families. There is coordination to accept referrals from several key community initiatives with similar aims.

Clinical intervention services are implemented individually in homes and other therapeutic and virtual settings with families and children ages 2 to 18. Programs conduct a comprehensive needs assessment to develop a treatment plan with each family. Families receive therapeutic services, such as psychoeducation, parenting consultation, behavioral health, and family therapy, to improve parent-child relationships while reducing parent stress and child disruptive behavior. A few programs enhance their models with natural helper supports that encourage treatment engagement and follow-through on needed behavioral health, substance abuse, and other parenting services. Programs can offer assistance by virtual delivery for some participants using telehealth and other technology to be responsive to participant needs.

**Description of Services:** All parents and families, regardless of their circumstances, face inevitable parenting challenges and can benefit from learning evidence-based strategies that support children's healthy development from prenatal to adolescence. Effective, consistent, and supportive parenting prepares children for a lifetime of success. Brief universal interventions can offer an effective, low-cost way to reach large and diverse groups of primary caregivers who might not otherwise receive parenting education. Improved parenting will support positive child outcomes related to emotional, behavioral, social, cognitive competence, and physical health and safety.

The Children's Trust Parent Club was launched in September 2019. Brief, evidence-based parenting workshops are delivered in English, Spanish and Haitian Creole for diverse groups of primary caregivers across Miami-Dade County to enhance awareness and knowledge for parents with children birth to age 16. These group contacts with parents also strengthen social supports by connecting parents with one another and linking families who have additional needs with appropriate services. Be Strong International, Inc., FIU and UM offer a combination of in-person and virtual, one-session group parenting workshops. Topics address common parenting strategies for parents of all abilities and information about available community resources.

The Children's Trust Parent Club uses a collaborative approach among the three funded agencies, as well as The Children's Trust and Miami-Dade County Public Schools Department of Family Support Services, which helps promote the program among its students and parents, and provides a forum, at no cost, for the workshops. There is a common set of collaboratively developed operating procedures so that anyone attending a Parent Club workshop has a similar experience, regardless of which of the three agencies provides it.

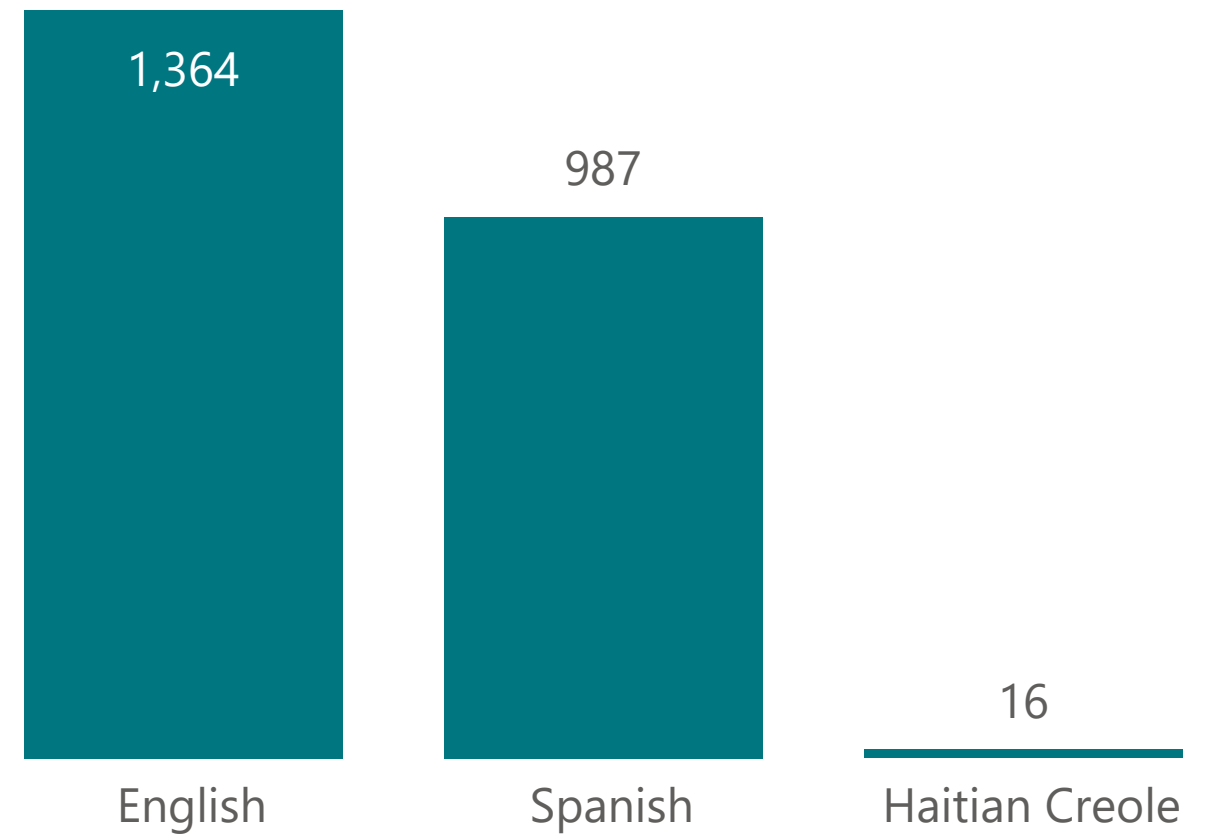

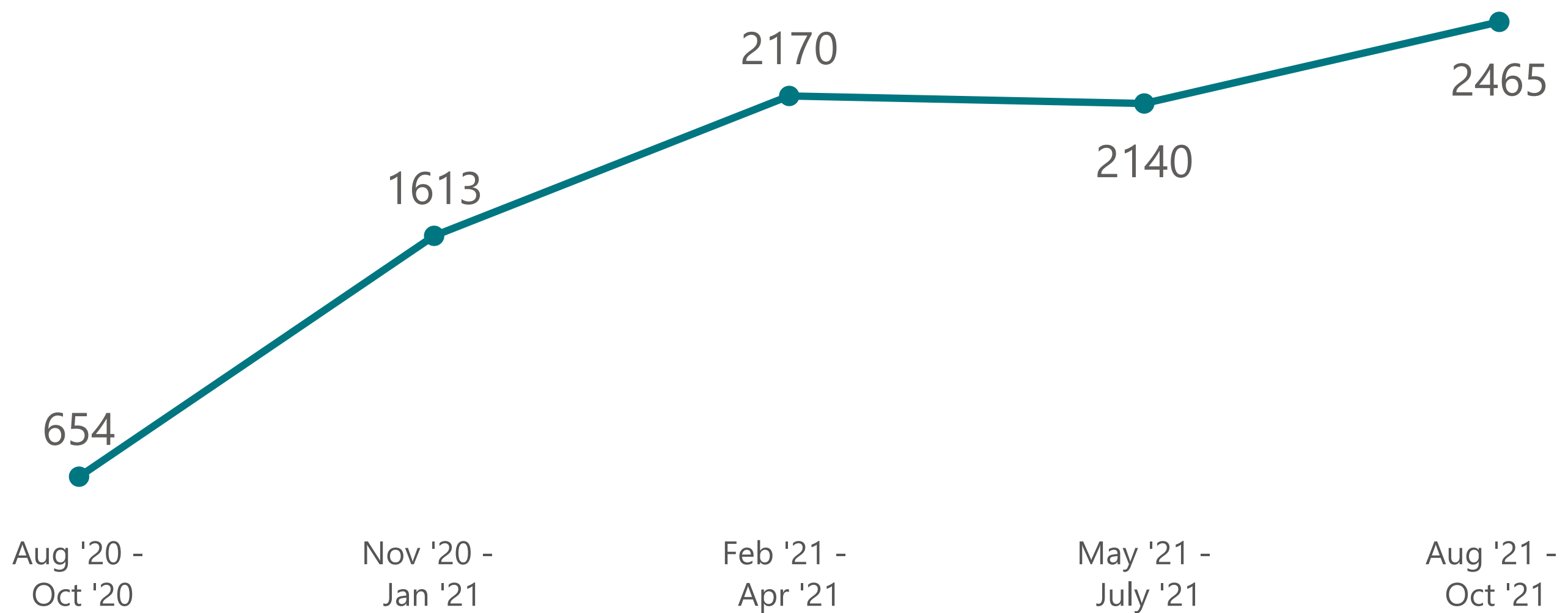

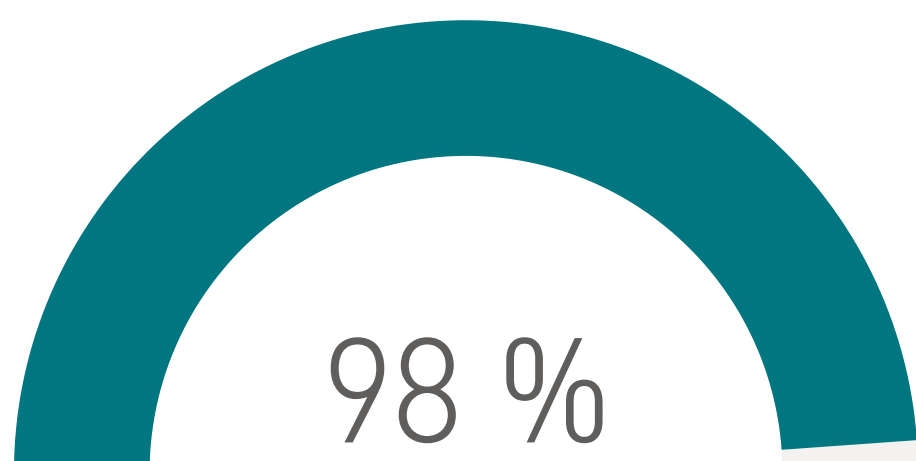

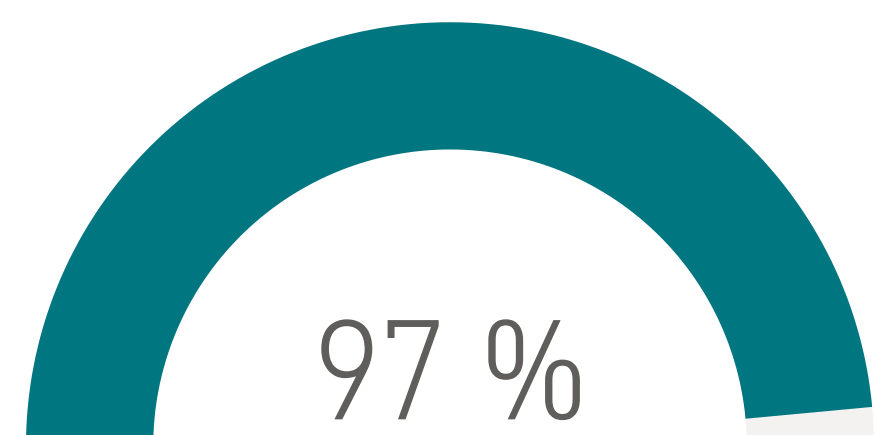
ATTENDANCE BY QUARTER

**Strategic Plan Priority Investment Area:** Parenting: Early literacy programs

**Strategic Plan Headline Community Results:** Children are supported by nurturing and involved parents; and children are ready for kindergarten.

**Recommended Action:** Authorization to negotiate and execute renewal contracts with the Miami-Dade Family Learning Partnership, Inc. and All in One Mail Shop, Inc. d/b/a All in One Direct Marketing Solutions for the support and maintenance of a birth to five book club, in a total amount not to exceed \$2,317,239.00, for a term of 12 months, commencing October 1, 2022, and ending September 30, 2023, with two remaining 12-month renewals.

**Budget Impact:** Funding in the amount of \$2,317,239.00 for this resolution is projected to be available in FY 2022-2023.

---

**Description of Services:** The Children's Trust Book Club provides free, monthly age-appropriate books and supporting materials to families in Miami-Dade County with children from birth to their fifth birthday. By participating in the Book Club, parents and caregivers are provided with the means to help their children build strong learning and social skills. The opportunity to remain in The Children's Trust Book Club for five years also increases touchpoints with parents, provides families with information and strategies that bolster early interactions, and supports child brain development and kindergarten school readiness.

National research indicates poverty is a leading indicator of limited early reading skills since it may contribute to lower school readiness, poor school attendance, and learning loss in the summer. These factors contribute to achievement gaps between children in low and middle-income households. To reduce these disparities, focused marketing and recruitment for this universal book club is prioritized in neighborhoods where early child development, kindergarten readiness and third grade reading levels are historically lower, and rates of lower socio-economic status are higher than the county average.

The Children's Trust's Book Club is part of the community-wide campaign for grade-level reading in Miami-Dade County. The campaign focuses on increasing high-quality early learning experiences, including early access to books in English and Spanish, and early parent-child reading interactions supported by parent-friendly guides for developmentally appropriate practices with young children.

The Children's Trust Book Club is comprised of four implementation components, which include the following key services:

- **Content Revision/Development and Book Buying** – Includes the: (i) selection of developmentally-appropriate books for young children, (ii) revision and creation of culturally-relevant content and activities to accompany the books, inclusive of content for children with disabilities, (iii) revision and development of digital content, activities

that support early literacy, math and social-emotional skills, and (iv) procurement of books.

- **Professional Fulfillment Services** – Includes packaging and monthly mailing of the books and accompanying materials, as well as printing of all supporting materials and envelopes.
- **Marketing** – Includes the creation and implementation of specialized marketing campaigns and other supporting collateral materials for grassroots outreach efforts. This component is approved under a separate resolution (Resolution 2022-20) for marketing services.
- **Ongoing Operations** – Includes project and vendor management, relationship building to coordinate outreach and enrollment with other early childhood organizations and the community, customer service, and day-to-day oversight. These tasks are carried out by a dedicated Children’s Trust staff member. The Book Club’s existing software management solution was redesigned and upgraded to assist with the management of operational tasks.

Vendors for the above-described implementation components and The Children’s Trust are working together to ensure coordination and effective operations. The following vendors are recommended for contract renewals.

The requested increase from FY 21-22 of \$75,015 for professional fulfillment services is due to rising costs of paper, printing, fuel and other direct effects on fulfillment services. This request also reflects a decrease of \$19,800 in the budget for content development, as a full year’s worth of supporting materials (61 family reading guides) have already been developed.

**Background:** The Children’s Trust issued a request for proposals (RFP) #2019-10, on March 27, 2019, to fund one or more vendors to implement The Children’s Trust expanded Book Club. Applicants could apply for one or more of three implementation components in the RFP: content development and book-buying; professional fulfillment services; and ongoing operations. Two agencies were funded for the Book Club’s content development/book buying and professional fulfillment services components. The operations, functions, and marketing of the Book Club are managed by The Children’s Trust and contracted marketing vendors.

Numerous early childhood organizations that comprise The Children’s Trust Book Club Community Advisory Committee collaborated and supported the efforts to develop the family reading guides and assist in guiding the expansion of the Book Club. These members include:

During the current contract year 2021-2022, 12 months’ worth of content guides were revised for branding and design. An overall marketing campaign with associated marketing co-branded collateral materials was also executed. During FY\_21-22 the following Advisory Committee members who receive payment from the Miami-Dade Family Learning Partnership,

Inc., were compensated for reviewing branding and design of all reading guides and book activity.

Additional guide development for FY \*22-23 is not anticipated at this time but may be required if a particular book is no longer available or a book selection must be changed, due to increased book cost as such, at this time funding is not allocated to the Advisory Committee members in FY 22-23 for guide development.

Numerous organizations partnered with The Children's Trust Book Club to disseminate these co-branded marketing materials.

The Book Club reached its target goal of 40,000 active members and plans to continue to retain that number for FY 22-23, by balancing ongoing enrollment efforts with monthly attrition rates.

**Strategic Plan Headline Community Results:** Children are supported by nurturing and involved parents; children are ready for kindergarten; and students are succeeding academically.

**Recommended Action:** Authorization to negotiate and execute a final contract renewal with Miami Dade College for The Children's Trust Books for Free program, in a total amount not to exceed \$450,000.00, for a term of 12 months, commencing October 1, 2022, and ending September 30, 2023.

**Budget Impact:** Funding in the amount of \$450,000.00 for this resolution is projected to be available in FY 2022-2023.

---

**Description of Services:** The Children's Trust Books for Free program ensures young children (through age 8) have access to books to take home and keep at no cost from bookshelves placed in public spaces throughout Miami-Dade County. To administer the program, Miami Dade College (MDC) engages communities, businesses, volunteers, and the public sector to collect, sort, and categorize donated gently used and newly purchased books. MDC then distributes the books through 65 bookshelves maintained in public places where parents and children frequent, such as Women, Infant and Children offices and community organizations in under-resourced neighborhoods. This program has a minimum annual 15 percent match requirement in cash or in-kind resources from MDC. Recent rebranding of the program changed the program name from Read to Learn Books for Free, to the current name The Children's Trust Books for Free.

**Background:** On July 9, 2018, the board of The Children's Trust approved the funding recommendation from the competitive request for proposals, RFP# 2018-04, for a five-year funding cycle, following a comprehensive review process. Upon considering the renewal of this contract, The Children's Trust assessed this program's progress and determined the provider is performing satisfactorily and meeting contractual benchmarks.

The program adjusted and pivoted during COVID-19 restrictions to meet community needs by extending its distribution model to include barbershops and laundromats. This partnership established with Kiwanis of North Dade and Kiwanis of South Dade, once fully implemented, will increase the bookshelves service sites from 65 to 72 this contract year. The cost of additional services for the seven new sites can be absorbed temporarily into the current contract as MDC experienced some staffing vacancies, resulting in the current flexibility to increase the number of bookshelf locations. Services within barbershop and laundromat sites required purchase of nonstandard bookshelves. The increase in the frequency of deliveries also required revised signage and marketing materials to accommodate the smaller service locations. The recommended funding amount for next year is higher than the current year

because The Children's Trust and Miami Dade College want to maintain the additional seven service sites established due to increased demand. The additional \$50,000 will support year-round operations for all 72 sites.

During the current year, Miami Dade College and the Books for Free program continued to adjust program operations due to COVID-19 restrictions. They moved to full operations of all the contracted bookshelf sites and further developed the new partnership with the Kiwanis Clubs. During the contract year 20-21 (October 1, 2020– September 2021), Miami Dade College successfully:

- Operated 73 bookshelf sites that received regular deliveries.
- Installed bookshelves at 10 new/replacement locations.
- Collected 52,987 and distributed 114,420 books.
- Provided book donations to 20 community partner book donations.
- Provided more than 50 percent in-kind match to the program, leveraging an additional \$223,921 value into the program.

During the first quarter of the current 21-22 contract year, MDC distributed 31,742 books with services to 70 bookshelves, exceeding the number currently contracted sites.

**Description of Services:** Reach Out and Read (ROR) is an evidence-based model that has been funded by The Children's Trust as part of the parenting early literacy support since 2015. This national model, endorsed by the American Academy of Pediatrics, champions the positive effects of reading daily and engaging in other language-rich activities with young children. The program provides families with children six months to 5 years of age with developmentally-age-appropriate books in English, Spanish and Haitian Creole, accompanied by pediatrician guidance about reading aloud. This program is provided in primary pediatric care settings, and at least half of the population serviced by the ROR clinic must be uninsured or publicly insured patients. Though rates of in-person well child visits were lower, the on-going pandemic impacted Miami-Dade Family Learning Partnership partnered with 70 pediatric clinics across the county to distribute nearly 47,000 books from July 2020 to June 2021.

**Background:** Miami-Dade Family Learning Partnership holds exclusive distributor rights for the ROR program in Florida. This distinction is awarded by the National Reach Out and Read Center. ROR is an essential component of the of The Trust's parenting supports and offers a special opportunity to encourage early literacy through trusted pediatric care providers.

Per The Children's Trust's procurement policy, section 2000, General Purchasing and Procurement Policy, Exemptions to Formal Competitive Procurement Process (G-4, single-source purchases), a competitive solicitation is not required.

**Strategic Plan Headline Community Results:** This investment supports all community results.

**Recommended Action:** Authorization to negotiate and execute a contract with Q-Q Research Consultants, LLC for research and evaluation services, in a total amount not to exceed \$261,734.00, for a term of 17 months, commencing retroactively on May 1, 2022, and ending September 30, 2023.

**Budget Impact:** Funding in the amount of \$261,734.00 for this resolution is allocated for FY 2021-22 and is projected to be available in FY 2022-23.

---

**Description of Services:** As part of The Children's Trust funding requirements, we collect and analyze extensive data relating to the demographics and attendance of the families and children served through the Trust funded programs ("program participants"), the quality of programs delivered, and the outcomes achieved by program participants. This solicitation seeks to incorporate additional, timely feedback from potential and existing program participants to assess program participant needs, input and satisfaction regarding The Children's Trust funded programs. The goals are two-fold:

1. Strengthen The Children's Trust's understanding of potential program participants' needs and interests as we plan for future program investments.
2. Incorporate input and satisfaction feedback from current program participants to guide The Children's Trust and funded program providers' continuous learning and quality improvement efforts.

Three specific survey projects are expected to be conducted, as described below. In future years, the specific projects will vary in purpose and population, but will continue to center around research and evaluation services to inform program participant needs, input, and satisfaction with Trust-funded programming.

- (1) After-school programs and summer camps: collect input from prospective and current program participants/parents on program design and elements that will meet their needs (e.g., program schedule, hours and duration, types of activities/focus of programming, locations, differences for school-year versus summer services, etc.).
- (2) Parenting education and support programs: collect input from prospective and current program participants' parents and caregivers on program design and elements that will meet their needs (e.g., program schedule, hours and duration, content, locations, format).
- (3) School-based health services: collect input from parents, potentially including current service users and/or general community sample, on service elements that will or have met their needs, as well as input from school personnel (e.g., principals, teachers) on perceived needs and implementation successes and challenges.

Survey design and administration will be conducted in English, Spanish and Haitian Creole. Budget includes participant research incentives for survey completion, and hybrid administration approaches will be used to maximize response rates (i.e., combining phone, text and online survey approaches). Mixed methods will be incorporated to triangulate input (i.e., enhancing survey results with focus group input or other relevant comparative community population or indicator data points).

Sampling approach will lead to generalizable results that support sound decision making about future investments in programs and services for children and families. Sampling will ensure representation of all major race/ethnicity and language groups in Miami-Dade County, as well as oversample families earning less than half the median household income for the county. The margin of error expected is four to eight percent at the 95% confidence interval.

**Background:** The Children’s Trust has not conducted community-level parent surveys for the purpose of understanding program participant needs in the past ten years. As part of our strategic planning related to the anticipated new funding cycles for youth development, parenting, and school health services, we are pursuing more robust input from potential service users. On April 6, 2022, The Children’s Trust released a request for proposals (RFP 2022-05), which closed on April 22, 2022. Four applications were received by the deadline and reviewed according to the solicitation guidelines and procurement policy. Based upon the reviews, Q-Q Research Consultants, LLC is recommended to carry out the research and evaluation services being sought.

This contract may be renewed for up to two additional 12-month terms. At year three, The Trust will assess the continued need for services, as well as vendor performance and determine renewal for up to two additional 12-month terms, for a cumulative total of five contract years of funding. The option to renew a contract shall be at the sole discretion of The Children’s Trust.

**Strategic Plan Headline Community Results:** Students are succeeding academically; children behave appropriately in schools, homes and communities; and youth successfully transition to adulthood.

**Recommended Action:** Authorization to negotiate and execute a funder collaboration contract with South Florida Workforce Investment Board (CareerSource South Florida) for a summer youth employment program for Miami-Dade County charter school students, in a total amount not to exceed \$500,000.00, for a term of 12 months, commencing on June 1, 2022, and ending on May 31, 2023, and to approve a waiver of the procurement policy requiring a 1 to 2 funder collaboration match requirement.

**Budget Impact:** Funding in the amount of \$500,000.00 for this resolution is projected to be available in FY 2022-2023.

---

**Description of Services:** This resolution seeks \$500,000.00 in funding from The Children's Trust to support a funder collaboration with the South Florida Workforce Investment Board (SFWIB) d/b/a CareerSource South Florida, and Miami-Dade County for a summer youth employment program for Miami-Dade County charter school students. The Children's Trust will contract with the SFWIB to pool funding for the program. SFWIB will manage and oversee the program's operation through the SFWIB's selected service provider Adult Mankind Organization Inc. (AMO). The SFWIB has authorized \$500,000.00 in match funding for the program and Miami-Dade County advises it will also commit a contribution of \$250,000.00.

The youth employment program will provide summer job opportunities for up to 450 youth residents of Miami-Dade County, between the ages of 15 and 18, who are enrolled in charter schools in Miami-Dade County. The program will provide entry-level positions with local businesses, in the public sector, and with community-based organizations. Youth enrolled in the program will also receive employability skills training. Youth participants will earn \$13.88 per hour (set by SFWIB) for 150 hours, 20 of which will be work readiness training. Participating youth will also receive financial literacy training and information related to budgeting and investing.

AMO will be responsible for administering the program, including payroll, recruitment, job placement, and work readiness training for the youth participants. The program is scheduled to begin on June 1, 2022, and end on September 25, 2022.

**Background:** In April 2022, the SFWIB requested funding to support a new summer employment program that would specifically recruit charter school students. This program is similar to other summer employment programs operated by the SFWIB in the Miami Gardens and Florida City areas. The program provides paid employment opportunities for a group of students not currently eligible for the Summer Youth Internship Program, operated by Miami-Dade County Public Schools. AMO reports previous job placements for participating students in various industries ranging from child care centers to the hospitality industry to law offices and is responsible for recruiting students and employers. Upon completing this initial summer youth employment program in 2022, Trust staff will conduct a full review of the program and determine whether future investment should be recommended for consideration for summer 2023.

**Procurement Policy: Request for Procurement Waiver of 1 to 2 funder collaboration match requirement (requires the approval of a 2/3 vote of board members present). The funder collaboration has a 1 to 1.5 match at this time. As it is a new program, additional funders may be sought to join the collaboration in the future.**

Per the procurement policy, section 2006 Match Funding and Funder Collaboration, the negotiation and execution of a funder collaboration contract are exempt from the competitive solicitation process. Renewal of match and funder collaboration funding beyond the initial contract term is at the sole discretion of The Children's Trust and shall be contingent upon satisfactory performance evaluations, quality program results, outcome achievements, availability of funding, and an ability to maintain the underlying primary funding source(s).






