These actions were taken by the Finance & Operations Committee meeting held on January 12, 2023 with a quorum of members physically present and some members attending virtually:

Motion to approve the November 3, 2022 Finance & Operations committee meeting minutes was made by Javier Reyes and seconded by Annie Neasman. Motion passed unanimously, 4-0.

**Resolution 2023-A:** Motion to recommend the resolution to the Board of Directors on January 23, 2023 was made by Hon. Norman Gerstein and seconded by Javier Reyes. Authorization to release competitive solicitations, in alignment with the board's strategic priorities and projected available funding, across multiple investment areas with funding cycles that have ended or are ending within the 2022-2023 fiscal year. **Motion passed unanimously, 4-0.** 

Resolution 2023-B: Motion to recommend the resolution to the Board of Directors on January 23, 2023 was made by Annie Neasman and seconded by Javier Reyes Authorization to release multiple competitive solicitations that support the infrastructure of The Children's Trust. Motion passed unanimously, 4-0.

Resolution 2023-C: Motion to recommend the resolution to the Board of Directors on January 23, 2023 was made by Javier Reyes and seconded by Annie Neasman. Authorization to expend up to \$49,999.00 for Kaufman, Rossin & Co. to act as technical advisors for a term of 10 months, commencing retroactively on December 1, 2022, and ending September 30, 2023. **Strategic Plan Priority Investment Area:** Community Awareness & Advocacy: Public Awareness & Program Promotion.

**Strategic Plan Headline Community Results:** This investment supports all headline community results.

Recommended Action: Authorization to negotiate and execute contract renewals for

advertising creative, media buying, and community outreach services, in a combined total amount not to exceed \$2,115,000.00, for a term of 12 months, commencing October 1, 2023, and ending

on September 30, 2024, with no remaining renewals.

**Budget Impact:** Funding in the amount of \$2,115,000.00 for this resolution is

projected to be available in FY 2023-2024.

**Description of Services:** The three agencies listed below provide advertising creative, media buying, and community outreach services for marketing campaigns related to The Children's Trust's branding, signature events, and the promotion of funded programs in areas such as literacy, early childhood development, children's health, after-school, summer learning, youth enrichment, quality child care, parenting, and adoption.

**Agencia Central LLC** provides creative services related to marketing and advertising, including but not limited to graphic design and the development and execution of effective trilingual advertising campaigns. This includes creating broadcast, print, outdoor, and digital media elements for multimedia public awareness, branding, and marketing campaigns. These campaigns are related to The Children's Trust's signature events and promotion of funded programs and initiatives. Agencia Central LLC has provided creative services for The Book Club, Thrive by 5, Parent Club, the 20<sup>th</sup> Anniversary campaign, and other Trust campaigns and initiatives in the current fiscal year.

**WOW Factor Marketing Group** purchases media buys with television and radio broadcasting stations, print, digital, and/or outdoor media. The media buys include:

- 1. Obtaining and analyzing data and research to develop a comprehensive media plan best suited to successfully delivering messages for the programs and initiatives being promoted.
- 2. Negotiating best rates and additional benefits on multiple media platforms, such as no-cost tv/radio spots, print/digital ads, and/or additional outdoor media spaces.
- 3. Paying selected and approved media.
- 4. Reconciling monthly/annual buys by analyzing results on a case-by-case basis to determine if goals were achieved and contractual obligations were met while obtaining "added value" benefits, including additional advertising given at no cost.

#### **Armstrong Creative** develops and executes:

- 1. A multilayered faith-based community outreach strategy in Miami-Dade County involving approximately 80 houses of worship.
- 2. Targeted media buying on urban media outlets.
- 3. Other outreach services specific to the African American community.

Additionally, Armstrong manages Haitian Creole marketing and outreach efforts, which include negotiating discounted media buys with targeted Haitian Creole television and radio broadcasting stations and other Haitian Creole media as needed; and providing community outreach specific to the Haitian Creole-speaking community.

Funding for these services is projected in both the Communications and Parenting budgets for FY 2023-2024. Each agency is recommended for renewal as follows:

The Book Club budget (within the Parenting budget) supports the marketing and advertising efforts for The Children's Trust Book Club. The \$100,000.00 increase supports the significant additional direct community outreach efforts led by Armstrong Creative as part of the recently approved Book Club expansion engagement initiative in the Haitian American community. The shift of \$75,000.00 from WOW Factor Marketing Group to Armstrong Creative will support the increase in direct costs of media purchases in the African American and Haitian communities that have grown exponentially. This adjustment will not increase the Communications budget.

**Background:** On February 18, 2020, The Children's Trust board approved the funding recommendations from the competitive requests for proposals, RFPs #2020-01 and 2020-02, for a five-year funding cycle, following a comprehensive review process. On January 18, 2022, by resolution #2022-20 the board approved the renewal of these contracts for FY 22-23. The total funding amount requested for the Communications budget this year is at the same level as FY 22-23. All communication efforts are ongoingly evaluated.

All three agencies have demonstrated proven knowledge in their respective areas and have consistently delivered excellent results.

**Budget Impact:** 

Funding in the amount of 3,090,956.00 for this resolution was allocated for FY 2021-2022 and requires a budget amendment for FY 2022-2023.

Approval of this resolution will amend the FY 2022-2023 budget with following adjustments:

- Youth Development (K-5 & 6-12): Increase total allocation to accommodate additional funds requested to be allocated in the chart below.
- Parenting (Parent Club & Family Strengthening): Increase total allocation to accommodate additional funds requested to be allocated in the chart below.
- Family & Neighborhood Support Partnerships (Partnerships): Increase total allocation to accommodate additional funds requested to be allocated in the chart below. Additionally, to add funds needed to total initiative allocation to support the pooled family stabilization purchase order, previously approved in Resolution number 2022-56.

Specifically, the Youth Development, Parenting, and Family & Neighborhood Support Partnerships resolutions authorized the president & CEO to approve contract renewals with the providers identified in the table below. All programs are recommended for this one-time grant of additional funding to go toward the current contract year (2022-2023) to cover expenses related to the increased costs to retain staff, increase costs to maintain high quality program operations and, for the Youth Development contracts, to cover costs associated with a two-week extension of the contract term (to August 14) that is likewise being requested in this resolution. The Youth development initiative contracts operate on an August 1 contract start date, while all other initiatives have contract terms that begin on October 1.

**Background:** During contract negotiations for approved contract renewals, many providers expressed concerns about their ability to recruit and maintain staff while mitigating the fiscal impact on day-to-day program operations. The programs listed above indicated that they had additional needs that could not be covered within their existing budgets. Trust staff met with each of the providers to review current budgets to determine if the needs could be met without additional funds. As a result of these negotiations and budget review meetings, the above funding increases are recommended for these contracts. These numbers align with the budget analyses conducted by Trust finance and programs staff of providers' historical expenditures and their unit costs.
